High Efficiency Heat Pumps

PROGRAM CHANGE FOR 2024:

- 15 SEER incentive is no longer available.
 - ▶ Any 15 SEER installations must be completed by December 31, 2023 to be eligible.

PROGRAM CHANGE FOR 2024:

- Incentive to be limited to \$1,500 per incentive
 - 20% incentive on any electric chainsaws, tillers, snow blowers, or lawn mowers

Agriculture Program

PROGRAM CHANGE FOR 2024:

- The Agriculture Program will include five individual prescriptive programs:
 - ► Center Pivot/Linear Outlet Component Replacement
 - \$500 for replacement of nozzles, sprayers, sprinkler heads, and regulators (if used)
 - ► Irrigation Moisture Sensors
 - \$300 for installing a moisture sensor with an irrigation management program
 - ► Corner Pivot Variable Frequency Drive (VFD)
 - \$18/hp
 - ➤ Automated Grain Aeration
 - \$.011 per bushel of bin capacity
 - ► Hog Heat Mats
 - \$40 or \$80 per mat (depending on size)
 - ▶ Pump Testing
 - Up to \$350 for having a professional efficiency test conducted on electric irrigation pumps
- A Custom Ag incentive is available for projects that are not part of the prescriptive programs.
